FUNCTION 3 CBTA_IATA-DGR

Program and Legal Requirements for Training in the Air Transport of Dangerous Goods

Mandatory Accreditation for Preparing Dangerous Goods Shipments, Including the Signing of Dangerous Goods Shipper's Declarations (DGD), in Compliance with Part 5 of ICAO-TI Regulations and Section 1.3.2 of IATA-DGR. Signing a DGD without the required accreditation in Spain is subject to fines of up to €250,000 (Articles 56.2 and 55.2 of Law 21/2003 on Air Safety) and may be legally penalized in certain countries. This course meets the updated competency-based training and assessment (CBTA) requirements outlined in Part 1, Chapter 4 of ICAO-TI regulations and Subsection 1.5 of IATA-DGR regulations.

La reglamentación que regula en España el transporte aéreo de mercancías peligrosas en la aviación civil está alineada con la reglamentación internacional de la Organización de Aviación Civil Internacional de Naciones Unidas - OACI (ICAO-TI - International Civil Aviation Organization, en sus siglas en inglés). Principalmente esta legislación se plasma en las siguientes referencias legale The regulations governing the air transport of dangerous goods in Spain are aligned with the international standards set forth by the United Nations International Civil Aviation Organization (ICAO-TI – International Civil Aviation Organization Technical Instructions). This legislation is primarily reflected in the following legal references:

- Law 21/2003 of July 7, on Air Safety.
- **ICAO Technical Instructions** for the Safe Transport of Dangerous Goods by Air, published every two years in the Official State Bulletin, in line with the ICAO update cycle for these Technical Instructions.
- **IATA-DGR (Dangerous Goods Regulations)** of the International Air Transport Association (IATA), which integrates ICAO's Technical Instructions and includes additional requirements from IATA.

The ICAO Technical Instructions stipulate that employers responsible for ensuring that dangerous goods are transported in compliance with legal requirements must establish and maintain a dangerous goods training program.

The **"employer**" figure and their legal obligations regarding training have been introduced by ICAO Technical Instructions and are applicable as of January 1, 2023. These instructions state that <u>individuals or entities engaged in air transport of dangerous goods must implement and maintain a competency-based training and assessment program</u>.

The training and assessment of personnel preparing dangerous goods shipments for air transport will be tailored to address the specific situations requiring training and evaluation.
